Accidental Dismemberment (Including Loss of Sight or Hearing): If the injury results in one of the losses as shown below, then a percentage of the sum insured is payable :-

Speech and hearing in both ears	100%

Thumb and index finger of same hand	25%

Accidental Weekly / Temporary Total Disability (TTD) : If the Injury results in TTD which wholly & continuously prevents the Insured from performing duties pertaining to occupation then the specified weekly amount will be payable per week upto 52 weeks.
